# MEMBERSHIP FEES FOR 2015

As with everything else these days, the cost of insurance is always going up.

It is with great reluctance therefore that the committee advises that from 1<sup>st</sup> January 2015, the Annual Membership fee for the Primary handler for each dog will increase to £10. The Membership fee for additional handlers will remain at £5 per annum and membership for children under 16 accompanied by a paid up adult member will still be free.

Eg if mum. dad and three children under 16 all attend classes at various times, membership will be £15 for the family. For an individual with one or more dogs it will be £10. For a couple it will be £15. The membership fee is per person - not per dog, so whether you own, 1, 2 or 4 dogs the membership fee for the primary handler is the same - £10

To ensure that everyone at the club is covered under the terms of our insurance, ANYONE who is a handler MUST be a paid up member and ANYONE who accompanies a child member MUST be a paid up member.

Membership fees are due on  $1^{st}$  January so your trainers will be requesting Membership fees when you start back in the New Year

## "FRIENDS" of Laleham Dog Training Club

The Club recognises that some of you like to stay on the Club's mailing list purely to receive the newsletters and to attend some of our events, seminars, Christmas parties etc. and to support us in this way.

As you will not be handling a dog in classes, you can continue to receive newsletters (by email) and attend events by becoming a "FRIEND" of Laleham Dog Training Club for £5 per year.

## Course Fees For 2015

To ensure we continue to provide good quality training in safe and suitable conditions, we are regrettably going to have to increase the cost of our courses from  $1^{\rm st}$  January 2015 as follows: -

An 8 week Obedience course (Puppy, Bronze, Silver & Gold) will be £50 A 10 week Agility course (all levels) will be £60

These prices are still less than those charged by other training venues in the area and still represent excellent value for money.

NB If you have already started a course in 2014, there will be no increase for the remainder of that 8 week obedience course or 10 week agility course. The increased prices will only be effective for NEW courses starting in 2015.

The Kennel Club will not allow a dog with the incorrect information on its Id tag to even take part in a Good Citizens Test. All dogs taking part in the Good Citizens tests <u>MUST</u> have the correct information. Any dog without the correct Id will NOT be permitted to take tests.

### DOGLAW: NEW POWERS TO TACKLE NUISANCE DOGS

Many of you may have read in the newspapers or heard through friends and on the grapevine that a new law has come into effect that will have serious repercussions if your dog chases next doors cat or warns off the postman. It is not quite as dramatic as the media is making out.

Trevor Cooper is a leading solicitor in a company that specialises in Dog Law. His firm have produced a DVD to explain the new powers that came into effect on 20<sup>th</sup> October 2014 as part of **The Anti-Social Behaviour, Crime & Policing Act 2014**. Having watched the DVD and read the accompanying notes, the following is a summary of the new powers and what they intend to do.

Basically, these provisions are aimed at "preventing, punishing and controlling" anti-social behaviour in dogs.

The Home Office defines Anti-social behaviour as: - "everyday nuisance, disorder and crime that has a huge impact on the victim's quality of life"

The purpose of the new provisions is meant to nip problems in the bud, empower victims & give professionals the tools they need to deal with situations.

Prior to 20/10/14 Councils had the power to make bylaws (**DOG CONTROL ORDERS**) to control dogs in public places, but now they will create **PUBLIC SPACES PROTECTION ORDERS (PSPOs)**. Existing Dog Control Orders make it a requirement to:-

- Pick up after your dog
- To keep a dog on a lead
- To put and keep a dog on a lead when directed to do so
- To exclude dogs (eg from children's play areas)
- To limit the number of dogs one person can have charge of.

These will be phased out over time and be converted to PSPOs.

PSPOs apply to a restricted area and can: -

- Prohibit specified things being done in that area
- Require specified things to be done by persons carrying out specified activities in that area
- Both the above

So PSPOs will include the 5 things covered already by DCOs but councils can also impose additional requirements. However, a council cannot just make any area a restricted area. They have to consider if there are suitable alternatives for dogs to be exercised without restrictions and whether any restrictions will affect those who rely on assistance dogs. Councils can therefore only apply PSPOs in order "To prevent the detrimental effect on the quality of life of those in the locality from continuing, occurring or recurring or To reduce the detrimental effect or reduce the risk of its continuance, occurrence or recurrence."

PSPOs can apply to: all persons/only to persons in specified categories/ or all persons except those in specified categories

Eg 1 professional dog walkers as opposed to general dog owners

Eg 2 disabled owners could be excluded

PSPOs can apply: at all times/at specified times/ or all times except those specified Eg beaches can have restrictions at different times of day and different months of the year

It's a criminal offence to fail to comply with a PSPO (unless there is a reasonable excuse). Maximum penalty is £1000. As an alternative to prosecution, an authorised person can issue a Fixed Penalty Notice of up to £100.

### **COMMUNITY PROTECTION NOTICE (CPNs)**

CPNs also came into effect on 20/10/14. Unlike PSPOs they will target individuals or organisations responsible for the nuisance and they are not limited to public land – they can apply to private land as well.

These powers are NEW. They do not replace existing powers or measures. They are intended to deal with "unreasonable, ongoing problems" or "nuisances which negatively affect the community's quality of life" by targeting the person responsible.

Before being served a CPN an individual must be given a written warning that the CPN will be issued unless the conduct ceases. They will be given sufficient time to stop the behaviour.

A CPN imposes requirements: -

- To stop doing specified things
- To do specified things
- To take reasonable steps to achieve specified results

Depending on circumstances a CPN could include an order to: - muzzle a dog/keep a dog on a lead/to have a dog neutered/exclude the dog from specific places/have the dog microchipped/ attend training

But the conduct being targeted must be having a detrimental effect and be persistent and unreasonable, so a CPN won't necessarily follow in cases of nuisance eg dog on dog minor incidents might be dealt with by an Acceptable Behaviour Contract or more serious incidents with an ASBO or a Civil Injunction (these will come into force shortly)

Examples of reasons for a CPN: -

- Out of control in the park
- Alarming visitors to the home
- Straying & causing damage
- A dog that distresses or injures other animals

If a person fails to comply with a CPN then the police or council can apply for a warrant to seize an item used in the commission of the offence – which could be the dog. The person can also be fined up to £2500 or up to £20,000 for an organisation.

If you are at all concerned about how these new laws might affect you and your dog you may borrow the DVD or read my full summary which I can email to you.

# **CHARITY UPDATE: -**





We have been advised by Hearing Dogs for Deaf People, that one of the puppies we have been sponsoring has reached the end of her training and has now been partnered with her recipient! What excellent news!

Jess is now two years old and has completed the final stages of her training to become a hearing dog - including learning to alert her new owner to the sound of a smoke alarm and a fire siren. Jess has been taught that when she hears one of these sounds, she must lie down at her owner's feet, but when asked "what is

it?" she does NOT lead her owner back to the source of the noise as this could mean she is potentially leading them both into danger. Instead she lies still and her owner then knows that Jess is alerting her to a serious signal.

Jess has now been homed with Sandy and her two sons in Bristol. Sally has been deaf since the age of 3. In the last few months, Jess has become a major part of family life and accompanied Sandy and the boys on many trips – camping, going to the beach and walking in the woods.

Sandy works as an occupational therapist in a community hospital. Jess goes to work with Sandy and usually lies curled up at her feet when Sandy is at her desk, or shadows her as she goes around doing her job.

As Jess's training is now complete, Hearing Dogs for Deaf People have asked if the Club would continue its sponsorship and have suggested a puppy called Berry. Berry is a cocker spaniel x miniature poodle puppy. Looking at that adorable bundle of fun, how could we refuse??
